

PRIVACY STATEMENT VEWOET B.V.

We value the importance of protecting personal data.

We process all personal data with due care and in compliance with the highest security standards. In processing personal data, we comply with the requirements of the General Data Protection Regulation (GDPR). Vewoet B.V. is responsible for all data processed on its systems. This Privacy Statement serves to explain what types of personal data we collect and use, and for what purpose.

Communication

If you send us an email or other communications, we may store these messages on our system. The types of personal data we request from you are restricted to your name, position/job title, and contact details such as your email address and telephone number. This enables us to process your questions and respond to your requests. The data is stored on our own secure servers. We will not merge this data with any other personal data in our possession.

Recording and Processing Data

We retain and use solely personal data provided by you directly or of which it is apparent on provision that the data is being shared with us. Any data which is no longer necessary will be deleted. You have the option to request access to or modification of your data, to object to the use of your data, request that use of your data be restricted, or that your data be deleted. Protection of Personal Data

We apply strict security procedures, including to prevent unauthorized individuals from gaining access to personal data.

Website Usage and Visitor Details

Use of Cookies and Google Analytics

We use cookies when providing electronic services. Cookies are small, simple text files stored on your computer's hard drive. We use temporary cookies, which contain no personal data and are used solely to facilitate the usage of the website. We use Google Analytics to track how visitors use our website. The information gathered in this manner is transferred to Google, including your computer's IP address, and subsequently stored on its servers. Please consult Google's privacy policy for further information, along with the specific Google Analytics privacy policy. Google uses this information to track how our website is used, to be able to provide us with reports on the website, and to be able to provide its advertisers with information on the effectiveness of their campaigns. Google may share this information with third parties if it is required by law to do so, or to the extent that such third parties process the information on behalf of Google. These processes are beyond the control of Vewoet B.V. We have not granted Google permission to use the Analytics information collected for the purpose of other Google services.
